In 2011 the Delaware County Community Foundation made 58 grants totaling \$196,657 to 50 different charitable organizations (list of non profits receiving grants is below). This included \$109,000 from the Home Health Care Fund to organizations providing home health care for individuals and families in Delaware County and \$25,000 from the Sunshine Fund to the Community Action Agency of Delaware County to provide emergency one-time assistance to county residents in crisis. Nine grants were issued by CAACD from the Sunshine fund to Delaware County residents.

The Hope for Children Fund was established in 2011 with a mission to provide the children of Delaware County who have been impacted by abuse or neglect with a safe environment advancing emotional and physical health, stability and resiliency. Through support of donors the fund received \$70,000 in pledges and donations. Grant distributions from this fund will begin in 2012.

DCCF added two new members to the Board of Directors. The Board supported DCCF by making contributions for operations, the Anniversary Gala, and Donor Advised Funds established at the foundation totaling \$42,648.
